



EQUINE RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT
(Last Updated 01/16/19)

I hereby enter into this agreement in consideration of my / ability and permission to ride OR use any Horse owned or operated by Adam and Heather Silverman on INNISFREE FARM whose address is 3509 Williamsport Pike. Williamsport, TN 38487.

IMPORTANT NOTICE BY SIGNING THIS AGREEMENT YOU ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGES IN CASE OF INJURY, DEATH, OR PROPERTY DAMAGE, ARISING OUT OF YOUR RIDING OR USE OF THE OWNER'S HORSE AND/OR PARTICIPATION IN EQUINE ACTIVITIES AT INNISFREE FARM INCLUDING INJURY, DEATH, OR PROPERTY DAMAGE ARISING OUT OF THE NEGLIGENCE OF YOU OR ANY EMPLOYEE OF INNISFREE FARM. READ THIS AGREEMENT CAREFULLY BEFORE SIGNING IT. YOUR SIGNATURE INDICATES YOUR UNDERSTANDING OF AND AGREEMENT TO ITS TERMS.

By signing this form, I hereby acknowledge on behalf of myself that I have familiarized myself with the activities that I will be allowed to participate in, and that I do hereby acknowledge and agree that I will participate in these activities without restriction or limitation. I recognize the inherent risks involved in riding and working with horses, including but not limited to: injury, Death or Property Damage. Innisfree Farm cannot control illness such as CoronaVirus (Covid-19). We will do our best to sterilize, but by being here, there is inherent risk. You must NOT have a family member with a fever over 99 or showing symptoms of sickness within 48 hours of riding here. If you have please - for the safety of all riders, staff, and animals - reschedule your lessons. We appreciate your attention to these matters.

I hereby specifically forever waive and release Innisfree Farm, Adam and Heather Silverman, and all of its principals and agents from any liability for injury arising out of the inherent risks from riding, working or participating in a stable environment and/or with horses, as well as from the active negligence of Innisfree Farm, owned by Adam and Heather Silverman, and its principals and agents. By signing this Agreement, or by initialing the paragraph below, I hereby acknowledge my complete understanding, agreement and consent to my presence and/or participation in the activities at Innisfree Farm without restriction, without liability to Innisfree Farm its principals or agents, and with full knowledge and understanding of the disclosures, waivers, and releases herein.

If I am present at and participate in the activities of Innisfree Farm I do so at my own risk, and I hereby acknowledge and agree that Innisfree Farm and/or any of its principals and agents shall bear no responsibility or risk associated with injuries that could arise from my presence or participation at Innisfree Farm.
